

**RESOLUTION N<sup>o</sup> 08-55**

**A RESOLUTION OF THE MAYOR AND COMMON COUNCIL OF THE TOWN OF DEWEY-HUMBOLDT, COUNTY OF YAVAPAI, ARIZONA, ADOPTING A NEW GENERAL PLAN FOR THE TOWN PURSUANT TO A.R.S. §9-461.06; AND PROVIDING THAT THIS RESOLUTION SHALL BE EFFECTIVE AFTER ITS PASSAGE AND APPROVAL ACCORDING TO LAW; AND THAT CERTAIN DOCUMENTS FILED WITH THE TOWN CLERK AND ENTITLED "TOWN OF DEWEY-HUMBOLDT 2008 GENERAL PLAN."**

WHEREAS, the adoption of the "Growing Smarter Act" (1998 Ariz. Sess. Laws, Chap. 204, §21) as amended by 1999 Ariz. Sess. Laws, Chap. 222, §2, the Arizona Legislature required the Town to adopt a General Plan; and

WHEREAS, after an extensive public process in accordance with said enactments, a draft "2008 Dewey-Humboldt General Plan" was considered by the Dewey-Humboldt Planning and Zoning Commission at a public hearing held May 8, 2008 at the Dewey-Humboldt Town Hall, resulting in a vote by the Commission to recommend adoption of the same by the Town Council; and


WHEREAS, the Town Council considered the "2008 Dewey-Humboldt General Plan" at a public hearing on June 3, 2008 at the Dewey-Humboldt Town Hall, and, at a continuance meeting on June 10, 2008 at the Dewey-Humboldt Town Hall, and adopted the same by this Resolution No.08-55 [subject to ratification by the voters per ARS §9-461.06(L)]; Therefore

**BE IT RESOLVED BY THE MAYOR AND COMMON COUNCIL OF THE TOWN OF DEWEY-HUMBOLDT, COUNTY OF YAVAPAI, ARIZONA:**


1. That certain document entitled "Town of Dewey-Humboldt 2008 General Plan", attached hereto and expressly made a part hereof, is hereby declared to be a public record within the meaning of A.R.S. §9-461.06, three copies of which are on file in the office of the Town Clerk and which are available for inspection by the public during normal business hours, is hereby adopted as the new General Plan of the Town of Dewey-Humboldt, pursuant to ARS §§9-461.05 and 9-461.06.
2. That the Town of Dewey-Humboldt Town Clerk be authorized to endorse said 2008 General Plan to show that it has been duly adopted by the Town Council, pursuant to ARS §9-461.06(G)
3. That this Resolution shall be effective after its passage and approval according to law.
4. That the Town Clerk shall ensure that this Plan is referred to the voters of the Town in the next General Election; and, if the voters fail to so ratify, that this Plan will remain in force until the next regularly scheduled major plan amendment, the

results of which will then be resubmitted to the voters of the Town in the then next General Election.


