AN ORDINANCE OF THE MAYOR AND COMMON COUNCIL OF THE TOWN OF DEWEY-HUMBOLDT, COUNTY OF YAVAPAI, ARIZONA, AMENDING THE TOWN OF DEWEY-HUMBOLDT, ARIZONA CODE OF ORDINANCES, TITLE III ADMINISTRATION, CHAPTER 30 TOWN COUNCIL AND OFFICIALS, SUBCHAPTER TOWN OFFICIALS, § 30.031 MAYOR AND VICE MAYOR; POWER AND DUTIES, APPOINTMENT OF VICE MAYOR, BY AMENDING PARAGRAPH (E) RELATED TO APPOINTMENT OF VICE MAYOR; PROVIDING FOR A SAVINGS CLAUSE; AND PROVIDING FOR REPEAL OF CONFLICTING ORDINANCES

Now, Therefore, Be it ordained by the Mayor and Common Council of the Town of Dewey-Humboldt, Arizona, as follows:

Section I. In General

The Town of Dewey-Humboldt, Arizona Code of Ordinances, Title III <u>Administration</u>, Chapter 30 <u>Town Council and Officials</u>, Subchapter <u>Town Officials</u>, Section 30.031 <u>Mayor and Vice Mayor</u>; <u>Power and Duties, Appointment of Vice Mayor</u>, Paragraph (E) is hereby amended to read as follows (additions in ALL CAPS; deletions in <u>strikeout</u>):

§ 30.031 Mayor and Vice Mayor; Powers and Duties; Appointment of Vice Mayor.

(E) Appointment of Vice Mayor; Term. Absent a vote of no-confidence, at the second REGULAR council meeting in December each year, the Town Council shall appoint the most senior Councilmember who has not already been the Vice Mayor AND HAS SERVED ON COUNCIL FOR AT LEAST ONE YEAR to the Vice Mayor position for a one-year term or until a new vice mayor is appointed. IF NO COUNCILMEMBER MEETS THE ABOVE CRITERIA OR THE PERSON TO BE APPOINTED DECLINES THE APPOINTMENT, THE MOST SENIOR COUNCILMEMBER SHALL BE APPOINTED TO SERVE AS VICE MAYOR FOR A ONE-YEAR TERM.

Section II. Savings Clause

If any section, subsection, sentence, clause, phrase, or portion of this Ordinance as amended is for any reason held to be invalid or unconstitutional by the decision of any court

of competent jurisdiction, such decision shall not affect the validity of the remainder of this Ordinance.

Section III. Repeal of Conflicting Ordinance

All other code provisions, ordinances, or parts of ordinances in conflict with the provisions of this Ordinance are hereby repealed as of the effective date hereof.
